ISC.05.1 WORKS PROGRAM - INFRASTRUCTURE SERVICES -

WATER & SEWER

PURPOSE

The purpose of the report is to provide an update on major works undertaken by the Water and Sewer team over the previous month and works planned for the upcoming month.

RECOMMENDATION

That the Committee

- 1. receive the report and note the information; and
- 2. endorse level of consultation Option 1. Letterbox drop of the plans and logic behind the decision to decommission the dam.

BACKGROUND

The report provides information to assist in addressing ratepayer enquiries regarding the operation, maintenance and other activities in the area of Water and Sewer.

Scone Water Treatment Plant (Joint with Muswellbrook Shire Council)

BECA attended the Brushy Hill site, on Thursday 27 May, to take the aerial images to develop the terrain model. The modelling is expected to be completed over the next two weeks.

Scone Sewerage Treatment Plant

The Scone Sewerage Treatment Plant is proposed to be replaced or upgraded depending on funding and/or technical capability of the existing plant.

In the last three months, an investigation has occurred into the performance of the intake works and the bioreactor (Bathurst Box). This investigation is likely to take two more months.

The initial assessment has found varying performance of the bioreactor, this is being investigated.



Infrastructure Services

Merriwa Sewerage Treatment Plant

The removal of sludge from the tertiary ponds by Dredging Solutions was due to start in late April but has been delayed 3-4 weeks due to the contractor being delayed by their previous works. Council has completed all the preparation works required to meet UHSC obligations.

The required land acquisition to install discharge pipework from the tertiary process dam to the river, as per the EPA licence agreement is continuing.

Sewer Relining Program

A contract has been awarded for the relining of sewer pipes in Murrurundi and Scone. Works on site are expected to commence in June 2023.

Water Main Renewal Work

Contract has been awarded to TCM for construction of nine (9) water main replacements in Murrurundi, Scone and Merriwa. Works have commenced in Satur Road Scone.

Sewer Main Repair Works

Sewer main access manhole and pipe repairs are continuing. The repairs were due to be completed by council staff but due to council staff unavailability will be rescheduled to be delivered by contractors.

Aberdeen River Pump Station Improvements

Aberdeen River Pump Station upgrade is complete. The electrical switchboards that supply the raw water pumps from the river have been replaced as well as the control systems.

Integrated Water Cycle Management Plan

Work is continuing on the Issues Paper. Additional work is occurring on above-ground asset assessments, Murrurundi pipe reticulation system modelling and peak day demand analysis. The IWCM issues paper is expected to be completed in around 4 weeks.

Village Water Supply - Parkville/ Wingen/ Blandford

The design for these dispensing stations is complete. The dispensing equipment has been quoted and will be ordered next week.

Scone to Murrurundi Pipeline

There are several easements yet to be finalised relating to the pipeline. The resolution of these easements will continue to be progressed for a further 5 months.

Glenbawn Dam pipework discharge

There has been a failure of a support bracket in the discharge tunnel at Glenbawn Dam. This has raised very significant engineering concerns about the structural capacity in a short section of the pipeline.

PWA provided an engineering proposal to undertake survey, modelling and a solution. This has been reviewed several times to minimise cost and ensure the scope of works is correct. It is expected that UHSC will engage the consultant next week.

Murrurundi Dam

In accordance with the process adopted at the last Infrastructure Services Committee meeting

- 1. Determine the initial case including
 - a. External Stakeholder meeting
 - b. Community notification/discussion
- 2. Making the case to maintain or decommission
 - a. Agreement with Council to decommission
- 3. Initial selection method of decommissioning
 - a. Decommission process to be designed
- 4. Deciding on decommissioning method
 - a. Decommissioning endorsed by Council
 - b. Decommissioning undertaken

Council had a meeting (1.a External stakeholder meeting) 2 May 2023 with identified external stakeholders on the Murrurundi Dam. In attendance at the meeting was Public Works, DPE, Health, EPA and NSW Fisheries. The purpose of the meeting was to determine if any agency had an interest in the Dam facility. Good discussion occurred with several points being raised including environmental benefits of not extracting water from the Pages River, the need to amend the water security licence transferring it to the Hunter River system and the need to update health on the water filtering system.

The next step of the process (1.b Community notification/discussion) is to undertake some level of public consultation. It is understood that the community may have concerns around water security in relation to the dam.

Options available on the levels of communication with the community are:

- 1. Letterbox drop of the plans and logic behind the decision to decommission the dam
- 2. Letterbox drop as above + Detailed analysis made available on the web
- 3. Letterbox drop as above + Community meeting to discuss concerns

The recommendation is to undertake Option 1 – Letterbox drop of the plans and logic behind the decision to decommission the dam.

The process being proposed has 4 stages:

- 1. Determining the initial case for decommissioning
- 2. Making a case to maintain or decommission a dam
- 3. Initial selection of a method of decommissioning
- 4. Deciding on the preferred method of decommissioning

Council would make a decision at the end of Stage 2 when all the relevant facts are confirmed and consultation is completed.

This committee is requested to endorse the process as detailed in the "Briefing Note – "Murrurundi Dam Future Use".

CONCLUSION

Recycled effluent water continues to be used at 100% level due to the current dry conditions. The recycled effluent water usage is expected to reduce now as we move into autumn and winter.

Project renewal works delivery continues, some projects like Merriwa Sewer Treatment Plant Sludge removal, water pipe renewal and sewer pipe relining will extend into the next financial year.

The Glenbawn Dam pipe discharge remains the highest risk item. The solution for this is progressing.

Murrurundi Dam future use is being explored with the first external stakeholder meeting occurring on Tuesday 2 May. Public consultation is the next step.

Key Activities

UHSC Damages Claim AGRN 987 (Event 6)

Damages claim **AGRN 987** relates to the storm event of 6 November 2021 (Event 6) and includes **683** identified damages across Council's road network.

AGRN 987 Essential Public Asset Reconstruction (EPAR) response application was submitted to TFNSW on 6 October 22.

TFNSW has given the approval to proceed with a letter sent to Council on 13 December 2022 advising that funding of \$2,971,840 has been approved.

Works have commenced onsite to repair the flood-damaged roads in the EPAR claim and the completion of works has been recorded in the recovery database.

Damages Claim for UHSC (AGRN 987) - Design and Investigation Package

UHSC submitted EPA restoration form for the Design & Investigation Package for flood damage to TFNSW on 11 November 2022.

Flood damage details for the following roads -

- Ashbrooke Road
- Coulsons Creek Road
- Ridgelands Road
- Rouchel Road

Following a tender evaluation process, the council has provided a recommendation to TFNSW for the engagement of a professional services consultant, RHM Consulting Engineers in Scone, to start the investigation and complete the necessary design works.

Council has submitted a strategic estimate for the construction works for all 6 flood-damaged sites.

Council has also prepared Minor Works Request for Quotation for all 6 flood damage sites.

TFNSW to review the strategic estimate and the EPAR Claim for the construction works

UHSC Damages Claim AGRN 1012 – Landslip on the Barrington Tops Forest Road

Council has submitted a flood damage claim to TFNSW in relation to AGRN 1012 for the damages related to the landslip on the Barrington Tops Forest Road.

A proposal for a geotechnical assessment has been confirmed and JC Geotechnics has been commissioned to carry out the geotechnical investigation and design works for the above project.

The contractor has completed the onsite borehole investigation works and provided a geotechnical factual report to council.

Council has also prepared a Review of Environmental Factors for Barrington Tops Forest Road. TFNSW has given verbal approval to proceed, and a formal funding letter is to follow. TFNSW to review the strategic estimate, geotechnical factual report and the EPAR claim for the construction works.

UHSC Damages Claim AGRN 1012 (Event 7) Cullingral Road (Crown Reserve)

Council has estimated the value of the damages claim to be \$41,100. The EPAR application was submitted to TFNSW on 12 January 2023.

UHSC Damages Claim AGRN 1034 (Event 8)

Council has estimated the value of the damages claim to be \$1.25 million. The EPAR application was submitted to TFNSW on 11 January 2023.

Fixing Local Roads Pothole Repair

Council has been successfully completed works under the NSW Government Fixing Local Roads Pothole Repair Grant to the sum of \$591,431.97. Works included routine and corrective maintenance of potholes in rigid and flexible pavements, sealed and unsealed roads. Staff concentrated on corrective maintenance across our sealed road network due to the number of hazardous sections requiring urgent attention particularly on MR62, Scone Road at Murdering Hut Gully.

Regional & Local Roads Repair Program

Council has been successful in securing funding from NSW Government under the Regional & Local Roads Repair Program to the sum of \$3,200,739.00.

Council staff and contractors will be working together to deliver these programs in 2023.

Initial Heavy Patching Program attached and Council has the scope to add additional roads.

Causeways Betterment Program

Council has been successful in securing funding from NSW Government under the Regional & Transport Recovery Package to the sum of \$1,872,00.00.

The project will provide concrete causeways to replace 35 existing gravel causeways across the Upper Hunter Shire.

Stormwater Betterment Program

Council has been successful in securing funding from NSW Government under the Regional & Transport Recovery Package to the sum of \$698,490.00.

The project will provide upgraded stormwater drainage for 44 road crossings across the Upper Hunter Shire.





PURPOSE

The purpose of the report is to provide an update on the Coulson's Creek Road (MR358) Rehabilitation Project.

RECOMMENDATION

That the Committee receive the report and note the information.

BACKGROUND

Upper Hunter Shire Council undertook the construction of the Merriwa to Willow Tree Road (Coulson's Creek Rd, also known as MR358) in December 2019.

Cracking of the pavement and downslope fill embankment appeared after completion of major earthworks in October and November 2019. Further cracking developed in February 2020.

Council engaged geotechnical engineers and after an initial site inspection on 3 March 2020, the geotechnical advice on the condition of road and associated infrastructure was to impose a 5 tonne load limit and single lane configuration. Further geotechnical investigations, fieldwork and daily, weekly and monthly monitoring has continued since then.

A Project Control Group (PCG) was formed in September 2020 with representatives from Upper Hunter Shire Council, Transport for New South Wales, Infrastructure New South Wales and Public Works Advisory. The PCG has been charged with managing the road and the related design and construction phases of the project.

In January 2021, the PCG recommended following the latest geotechnical inspections, that the road be closed to all traffic with the key criteria of cracking extending to and beyond the centreline of the road.

GHD – Detailed Design of Construction Rehabilitation

GHD have issued the Construction Documents (Design, Specifications and Review of Environmental Factors).

REPORT/PROPOSAL

Site Access

The locks and chains have been replaced.

Project Control Group

The PCG met on 4 April 2023 to discuss the construction tender, funding commitments and project management.

Remediation Earthworks (Early Earthworks)

The remediation works completed appear to have settled with only minor changes over the last six months.

GHD - Detailed Design of Construction Rehabilitation

GHD have completed all IFC drawings and documents.

Construction Rehabilitation Tender

The tender has closed. The tenders are being evaluated both on non-price and price criteria. A report will be submitted to the PCG for endorsement and then to Council for adoption and award at the May 2023 Council meeting.

State and Federal Funding

Funding applications are currently undergoing final review by both the State and Federal Governments. Once completed Council will be issued with a funding deed for execution.

The funding for the project has been given approval in principle by both State and Federal Governments.

- Evaluation of the tenders.
- Extension of tender validity period to 90 days
- PWA and staff working through tender departures and qualifications

Emerging issues:

- Approved funding deeds to be received for execution from both the State & Federal Governments

As noted previously in this report, an inspection at the toe (bottom) of the major failure revealed it has now reached the gully. Council staff have reported to the Environmental Protection Agency (EPA).

The rehabilitation and construction of Coulsons Creek Road is a substantial risk that will require appropriate management and control throughout the construction works.

e. Sustainability Implications

There are some significant environmental issues that include mass fill movements, tree loss, erosion and sediment controls. These must be addressed in the design process and form part of the review of environmental factors.

As noted the toe of the major failure has reached the gully. This was reported to the Environmental Protection Agency, on reviewing of the Issued For Construction Design and Review of Environmental Factors, and they have accepted the proposed control metohds.

The road is currently closed due to risk and safety concerns. Remedial (early) earthworks completed.

This report provides information to assist in understanding the current status of the project, what work has recently been completed and the work that is forecast for the next month, plus the revised forecast for the end of the project.

REPORT/PROPOSAL

Moonan Brook Road

Description of Works

Design and construction of the improvement, widening and initial seal of Moonan Brook Road, a total length of 3.5 km from the intersection with Hunter Road to just past the intersection with Barrington Tops Forest Road. This includes the upgrading of storm water drainage structures.

The Works will provide an improved level of service with greater access to the Moonan Brook Camping and Recreational Area and to the Barrington Tops National Park with increased safety by reducing the risk for road users with improved alignment and sight distances, additional safety barriers and signage. This will increase productivity for local primary producers and increase tourism within the region which will provide an increase to the local economy.

Start of Construction – February 2023 Open to Traffic – September 2023

BACKGROUND

This report provides information to assist in understanding the current status of the project, what work has recently been completed and the work that is forecast for the next month, plus the revised forecast for the end of the project.

REPORT/PROPOSAL

Description of Works

Daracon Contractors Pty Ltd have been appointed to undertake Stage 1 of the Scone CBD Revitalisation Project. Stage 1 is the redevelopment of Kelly Street between Kingdon and St Aubins Streets, including St Aubins Town Square.

The project comprises the construction of new wider footpaths, additional crossings and parking, road resurfacing, landscaping and upgrades to utilities (electrical, water and pedestrian lighting).

This period's progress summary

- The Road Occupancy Licence for Kelly Street was approved utilising a detour for northbound traffic between Liverpool Street and St Aubins.
- Contractor established facilities in Campbell's Corner car park.
- The Kelly Street northbound traffic detour between Liverpool Street and St Aubins St was implemented on the evening of Thursday 13 April 2023.
- Building condition assessments of adjacent structures was completed for the first phase of works with the remainder of the inspections ongoing.
- The replacement of the asbestos water main at St Aubins St was completed.
- Saw-cutting and removal of existing pavement and kerb commenced on Kelly Street between Liverpool Street and St Aubins Street.

Next period's planned activity summary

Kelly Street

- Continuation of saw-cutting and removal of existing pavement and kerb on Kelly Street between Liverpool Street and St Aubins Street.
- Excavation and installation of storm water drainage.
- Commencement of installation of new 150mm diameter water main.

St Aubins Square

- Completion of water main replacement works
- Demolition of existing road surface, kerbs and footpaths
- Excavation and installation of new storm water drainage
