PURPOSE

The purpose of the report is to provide an update on major works undertaken by the Water and Sewer team over the previous month and works planned for the upcoming month.

BACKGROUND

The report provides information to assist in addressing ratepayer enquiries regarding the operation, maintenance and other activities in the area of Water and Sewer.

Scone Water Treatment Plant (Joint with Muswellbrook Shire Council)

BECA have attended site and completed the aerial survey. They have completed preliminary concept designs, sizing, designed the plant layout, and drafting is scheduled for week commencing 4 June.



Scone Sewerage Treatment Plant

The Scone Sewerage Treatment Plant is proposed to be replaced or upgraded depending on funding and/or technical capability of the existing plant.

Over the last five months, Council staff have been investigating the performance of the current sewer treatment plant to inform decision on upgrade or replacement. The intent of this investigation has been completed with the significant findings being:

- The 'head of works' (primary treatment):
 - Observed hydraulic capacity limitations (overflow of channels) causes identified and rectified.
 - There is no grit (sand, fine egg shells, fine bone, etc) removal process installed nor has there been cleaning of downstream equipment where grit would accumulate for 20-25 years. The level of accumulated grit was estimated at around 0.2m in the Bathurst box that can be dealt with by cleaning at 10-20 year intervals.
 - The coarse debris screen is old but performing acceptably following recent maintenance.
- The **bioreactors** (secondary treatment (Bathurst Box (IDEA) and Trickle filter):
 - Assessed the performance of the main bioreactor (Bathurst Box). It shows variable performance in removing biodegradable matter and nitrogen. Council has identified the likely causes as:
 - Periods of inadequate aeration (solutions available).
 - Out of typical and treatable ratio of biodegradable matter (bug food) to nutrients.
 - Difficulty in managing sludge, likely due to machinery breakdown and the high non-degradable solids in the sewerage.
 - Assessed the performance of the secondary bioreactor (attached growth trickle filter).
 - As previously identified the clarifier shows poor performance leading to solids carryover.
 - It is a well-known limitation but worth mentioning that the trickle filter does not remove nutrients.
- Assessed the performance of **polishing ponds** and other **tertiary processes** (Chlorine) performance. Identified that the process is not removing pathogens as effectively as it should and the reuse water is of low health quality:
 - We suspect the high sludge levels within the polishing ponds (dams) to be affecting pathogen removal.
 - Poor performance of the trickling filter is feeding too many organisms and food to the polishing ponds.
 - A high reliance on chlorination in challenging conditions; remaining organic and chemicals and a short time for the chlorine to act.

The project to replace the Scone sewerage treatment plant (build a completely new sewer plant) was considered in 2017/2018 with a concept developed to meet contemporary health and environmental standards regardless of the cost of construction. The project did not continue as the estimated cost was far in excess of available funding. Once all options are considered, a report will be brought back to the next meeting.



Merriwa Sewerage Treatment Plant – Sludge Removal

The removal of sludge from the tertiary ponds commenced in the week 15 May with setup and operating within a week. The process now seems to be operating in a controlled manner with removal occurring at a steady rate. It is expected to continue for a further 9 weeks.

Sewer Relining Program

A contract has been awarded for the relining of sewer pipes in Murrurundi and Scone. Cleaning and CCTV works commenced on 29 May in Scone for a three (3) week period. The relining crew will commence 5 June in Satur Road for an expected eight (8) week program across Scone and Murrurundi.

Water Main Renewal Work

Contract has been awarded to TCM for construction of eleven (11) water main replacements in Murrurundi, Scone and Merriwa. Works are continuing in Satur Road Scone, Barton/Susan Streets. A second work crew was mobilised in May to meet work program.

Manhole Repair Works

Sewer main access manhole and pipe repairs are currently on hold pending finding resources to deliver. The repairs were due to be completed by Council staff but due to staff unavailability will be rescheduled to be delivered by contractors.

Four organisations have been approached to undertake works on an hourly hire basis. All have returned quotes for services. It is intended to engage two organisations for a few weeks and test their delivery ability and quality of work.

Aberdeen River Pump Station Improvements

Aberdeen River Pump Station upgrade is complete. Defects are being repaired to complete this contract.

Integrated Water Cycle Management Plan

There is currently a delay occurring within this process where Council has requested a variation to undertake an above ground assessment of all water and sewer assets for the IWCM. This variation is required to be approved through DPE in the next three months. It is expected that this delay will continue for several weeks or months.

However, work is continuing on the Issues Paper for other approved work. Work has commenced on the options analysis for identified components within the Issues Paper.

Village Water Supply - Parkville/ Wingen/ Blandford

Water fill stations have been delivered. Requests for quotes from concreting organisations have been sent to several companies and responses are due next week.

Scone to Murrurundi Pipeline

There are several easements yet to be finalised relating to the pipeline. The resolution of these easements will continue to be progressed for a further 4 months.



Glenbawn Dam pipework discharge

PWA have been provided with an order for the work in mid-May. This project is expected to take several months as there are several sub-consultants involved.

Murrurundi Dam

In accordance with the process adopted at the April 2023 Infrastructure Services Committee meeting, council officers are following the process below:

- 1. Determine the initial case including
 - a. External Stakeholder meeting
 - b. Community notification/discussion
- 2. Making the case to maintain or decommission
 - a. Agreement with Council to decommission
- 3. Initial selection method of decommissioning
 - a. Decommission process to be designed
- 4. Deciding on decommissioning method
 - a. Decommissioning endorsed by Council
 - b. Decommissioning undertaken

Council had a meeting (1.a External stakeholder meeting) 2 May 2023.

Council has completed a letterbox drop on 8 June to the residents, 1.b Community notification/discussion as per the attached document. Feedback responses are due 23 June 2023.

CONCLUSION

Recycled effluent water continues to be used at 100% level due to the current dry conditions and remains high even though we are moving into winter.

Project renewal works delivery is accelerating as we move towards the end of the financial year. There are several projects like Merriwa Sewer Treatment Plant Sludge removal, water pipe renewal and sewer pipe relining that will extend into the next financial year.

The Glenbawn Dam pipe discharge remains the highest risk item. The solution for this is progressing with the engagement of PWA.

The process to consider the future of Murrurundi Dam has completed the first external stakeholder meeting on Tuesday 2 May. Public consultation is the next step through a letter box flyer that has been delivered.

The future of Murrurundi Dam

Upper Hunter Shire Council is reviewing potential changes to the water supply in the Murrurundi township, primarily the decommissioning of the Murrurundi Dam. The Scone to Murrurundi pipeline, operational for three years now, is providing a reliable and effective water supply, leading Council to consider the dam's necessity.

We acknowledge that changes might concern residents and invite you to engage in this crucial process as we deliberate on the dam's future, weighing its maintenance costs, environmental impact, safety, and functionality.

Why consider removing the dam?

Due to its expensive maintenance and reduced necessity since the pipeline provides adequate water supply.

What happens during drought?

The Glenbawn Dam, supplying the pipeline, is expected to remain operational longer during drought than the Murrurundi Dam.

Are there environmental benefits to keep the dam?

Removing water extraction from the Pages River can improve river health and reduce electricity usage.

What about recreational uses of the dam?

Any uses requiring the dam to remain full will still incur most of the annual maintenance cost, hence not under consideration.

How will the dam be decommissioned and the site used?

Likely emptying the dam and modifying it to prevent refilling. Future site uses will be decided during the final stage.

What are the benefits of decommissioning?

Benefits include cost and electricity reduction, less maintenance, and reduced drowning risk.

When will decommissioning happen?

The decision by Council is expected to occur in the next two months, with further planning to follow. The decommissioning process should take 12 - 18 months.

Key Activities

UHSC Damages Claim AGRN 987 (Event 6)

Damages claim *AGRN 987* relates to the storm event of 6 November 2021 (Event 6) and includes **683** identified damages across Council's road network.

AGRN 987 Essential Public Asset Reconstruction (EPAR) response application was submitted to TFNSW on 6 October 22.

TFNSW has given the approval to proceed with a letter sent to Council on 13 December 2022 advising that funding of \$2,971,840 has been approved.

Works have commenced onsite to repair the flood-damaged roads in the EPAR claim and the completion of works has been recorded in the recovery database.

Damages Claim for UHSC (AGRN 987) - Design and Investigation Package

UHSC submitted EPA restoration form for the Design & Investigation Package for flood damage to TFNSW on 11 November 2022.

Flood damage details for the following roads -

- Ashbrooke Road
- Coulsons Creek Road
- Ridgelands Road
- Rouchel Road

Following a tender evaluation process, the council has provided a recommendation to TFNSW for the engagement of a professional services consultant, RHM Consulting Engineers in Scone, to start the investigation and complete the necessary design works.

Council has submitted a strategic estimate for the construction works for all 6 flood-damaged sites.

Council has also prepared Minor Works Request for Quotation for all 6 flood damage sites.

TFNSW to review the strategic estimate and the EPAR Claim for the construction works

UHSC Damages Claim AGRN 1012 – Landslip on the Barrington Tops Forest Road

Council has submitted a flood damage claim to TFNSW in relation to AGRN 1012 for the damages related to the landslip on the Barrington Tops Forest Road.

A proposal for a geotechnical assessment has been confirmed and JC Geotechnics has been commissioned to carry out the geotechnical investigation and design works for the above project.

The contractor has completed the onsite borehole investigation works and provided a geotechnical factual report to council.

Council has also prepared a Review of Environmental Factors for Barrington Tops Forest Road. TFNSW has given verbal approval to proceed, and a formal funding letter is to follow. TFNSW to review the strategic estimate, geotechnical factual report and the EPAR claim for the construction works.



UHSC Damages Claim AGRN 1012 (Event 7) Cullingral Road (Crown Reserve)

Council has estimated the value of the damages claim to be \$41,100. The EPAR application was submitted to TFNSW on 12 January 2023.

UHSC Damages Claim AGRN 1034 (Event 8)

Council has estimated the value of the damages claim to be \$1.25 million. The EPAR application was submitted to TFNSW on 11 January 2023.

Fixing Local Roads Pothole Repair

Council has been successfully completed works under the NSW Government Fixing Local Roads Pothole Repair Grant to the sum of \$591,431.97. Works included routine and corrective maintenance of potholes in rigid and flexible pavements, sealed and unsealed roads. Staff concentrated on corrective maintenance across our sealed road network due to the number of hazardous sections requiring urgent attention particularly on MR62, Scone Road at Murdering Hut Gully.

Regional & Local Roads Repair Program

Council has been successful in securing funding from NSW Government under the Regional & Local Roads Repair Program to the sum of \$3,200,739.00.

Council staff and contractors will be working together to deliver these programs in 2023.

Initial Heavy Patching Program attached and Council has the scope to add additional roads.

Causeways Betterment Program

Council has been successful in securing funding from NSW Government under the Regional & Transport Recovery Package to the sum of \$1,872,00.00.

The project will provide concrete causeways to replace 35 existing gravel causeways across the Upper Hunter Shire.

Stormwater Betterment Program

Council has been successful in securing funding from NSW Government under the Regional & Transport Recovery Package to the sum of \$698,490.00.

The project will provide upgraded stormwater drainage for 44 road crossings across the Upper Hunter Shire.



PURPOSE

The purpose of the report is to provide an update on the Coulson's Creek Road (MR358) Rehabilitation Project.

RECOMMENDATION

That the Committee receive the report and note the information.

BACKGROUND

Upper Hunter Shire Council undertook the construction of the Merriwa to Willow Tree Road (Coulson's Creek Rd, also known as MR358) in December 2019.

Cracking of the pavement and downslope fill embankment appeared after completion of major earthworks in October and November 2019. Further cracking developed in February 2020.

Council engaged geotechnical engineers and after an initial site inspection on 3 March 2020, the geotechnical advice on the condition of road and associated infrastructure was to impose a 5 tonne load limit and single lane configuration. Further geotechnical investigations, fieldwork and daily, weekly and monthly monitoring has continued since then.

A Project Control Group (PCG) was formed in September 2020 with representatives from Upper Hunter Shire Council, Transport for New South Wales, Infrastructure New South Wales and Public Works Advisory. The PCG has been charged with managing the road and the related design and construction phases of the project.

In January 2021, the PCG recommended following the latest geotechnical inspections, that the road be closed to all traffic with the key criteria of cracking extending to and beyond the centreline of the road.

GHD – Detailed Design of Construction Rehabilitation

GHD have issued the Construction Documents (Design, Specifications and Review of Environmental Factors).

REPORT/PROPOSAL

Site Access

The locks and chains have been replaced due to continued illegal access.

Project Control Group

The PCG met on 22 May 2023 to discuss the evaluation of the construction tender, funding commitments and project management.

Remediation Earthworks (Early Earthworks)

The remediation works completed appear to have settled with only minor changes over the last six months.

GHD – Detailed Design of Construction Rehabilitation

GHD have completed all IFC drawings and documents.

Construction Rehabilitation Tender

The tender has been evaluated both on non-price and price criteria. A report was tabled at the PCG for endorsement and then to Council for adoption and award at the May 2023 Council meeting, subject to funding deed.

State and Federal Funding

Funding applications are currently undergoing final review by both the State and Federal Governments. Once completed, Council will be issued with a funding deed for execution.

Council has received a letter confirming the State Government funding commitment for the project. The Federal Government has given approval in principle, however Council is still waiting on a letter confirming this.

Key activities for May 2023:

- Evaluation of the tenders went to May Council meeting with preferred tenderer subject to funding deed
- Evaluation of proposed project management teams

- Approved funding deeds to be received for execution from both the State & Federal Governments

The rehabilitation and construction of Coulsons Creek Road is a substantial risk that will require appropriate management and control throughout the construction works.

e. Sustainability Implications

There are some significant environmental issues that include mass fill movements, tree loss, erosion and sediment controls. These must be addressed in the design process and form part of the review of environmental factors.

As noted the toe of the major failure has reached the gully. This was reported to the Environmental Protection Agency, on reviewing of the Issued For Construction Design and Review of Environmental Factors, and they have accepted the proposed control methods.

REPORT/PROPOSAL

Moonan Brook Road

Description of Works

Design and construction of the improvement, widening and initial seal of Moonan Brook Road, a total length of 3.5 km from the intersection with Hunter Road to just past the intersection with Barrington Tops Forest Road. This includes the upgrading of storm water drainage structures.

The Works will provide an improved level of service with greater access to the Moonan Brook Camping and Recreational Area and to the Barrington Tops National Park with increased safety by reducing the risk for road users with improved alignment and sight distances, additional safety barriers and signage. This will increase productivity for local primary producers and increase tourism within the region which will provide an increase to the local economy.

Start of Construction – February 2023 Expected opening to Traffic – September 2023

This Period's Progress Summary

- Completion of 90% of cutting between chainages 2600 and 2740 by Nitro Civil Excavations. Progress slowed by a section of extremely hard rock
- Completion of cutting between chainages 2950 and 3150 by Nitro Civil Excavations
- Completion of grubbing and stripping for road widening by Vision Excavations
- Completion of relocation of fencing by Maximum Effort Contracting.



Next Period's Planned Activity

- Completion of second cutting
- Continuation of installation of drainage structures

Barrington Tops Forest Road

The Works will provide an improved level of service across the Barrington Tops. It will increase safety by reducing the risk for road users with improved alignment and sight distances, additional safety barriers and signage and road widening on corners where possible. This will increase tourism and productivity for local primary producers which will provide an increase to the local economy.

Start of Construction – September 2023 Expected opening to Traffic – May 2024
