#### ISC.03.1 WORKS PROGRAM - INFRASTRUCTURE SERVICES - WATER & SEWER

#### **PURPOSE**

The purpose of the report is to provide an update on major works undertaken by the Water and Sewer team over the previous month and works planned for the upcoming month.

#### RECOMMENDATION

That the Committee receive the report and note the information.

#### **BACKGROUND**

The report provides information to assist in addressing ratepayer enquiries regarding the operation, maintenance and other activities in the area of Water and Sewer.

#### Scone Water Treatment Plant (Joint with Muswellbrook Shire Council)

A Scone Water Treatment Plant PCG meeting was held on 7 March 2023.

At the meeting, the group:

- Endorsed the minutes of the previous meeting held 24 January 2023;
- Reviewed the assessment of other possible sites, developed by Gavin McKenzie, and discounted all options other than Gundy Road and Brushy Hill;
- Endorsed a plan to proceed with a single quote from BECA (Formerly Hunter H2O) to undertake 4 tasks to confirm the suitability of the Brushy Hill Site;
- Requested members to review pipeline alignments for the supply to Aberdeen and Muswellbrook; and

 Tasked the PCG technical experts to develop the criteria for assessing the locations of the water treatment plants.

#### **Scone Sewerage Treatment Plant**

The Scone Sewerage Treatment Plant is proposed to be replaced or upgraded depending on funding and/or technical capability of the existing plant.

Last month, an investigation commenced into the performance of the intake works and the bioreactor (Bathurst Box). This investigation is likely to take several months.

The initial assessment has found varying performance of the bioreactor. The quality of the output was less than expected. There are several courses of investigations being followed. Following this investigation, Council will have the knowledge if the plant can be upgraded or should be replaced.

Last month, the Project Manager attended technical training in sewer treatment plant design.

#### **Merriwa Sewerage Treatment Plant**

The contract has been awarded to Dredging Solutions for removal of sludge.

A commencement meeting is planned for 9 March 2023. The current delivery provides a start date of April 2023 and a completion September 2023.

The required land acquisition to install discharge pipework from the dam to the river is continuing.

#### **CCTV Sewer Relining Program**

Tenders to reline pipes have been received and are being assessed. A tender report is expected to be at March Council meeting to award the contract.

#### **Water Main Renewal Work**

Contract has been awarded to TCM for construction for 9 water main replacements. Scheduling of works will be detailed in future reports.

#### **Sewer Main Repair Works**

Sewer main access manhole refurbishments have commenced. This work is being delivered by both FITT Resources and Council.

#### **Aberdeen River Pump Station Improvements**

Prior to the shutdown of the Aberdeen River Pump Station, Council officers undertook a risk review of the turbidity and the algae levels within Scone's water system and at Glenbawn Dam inlet. It is the turbidity and algae that can cause a boiled water alert. The assessment confirmed no alarming levels of either and the decision to proceed with the works.

The Contractor, ETM commenced on site Monday 6 March 2023 for the electrical shutdown to replace the switchboard. The facility is now shutdown for 4 to 6 weeks.



#### **Infrastructure Services**

#### Village Water Supply - Parkville/ Wingen/ Blandford

At the February 27 2023 Council meeting, Council resolved the locations of the standpipes.

The sites have been inspected by Curran Consulting Engineers to design the concrete slabs for the infrastructure.

The Project Manager has sought quotes to procure the water filling stations. Quotes have been received and are currently being assessed.

#### Scone to Murrurundi Pipeline

Easements for the pipeline will continue to be progressed for a further 6 months.

#### Murrurundi Dam

In the 15 December 2022 Infrastructure report, it was identified that Council is reviewing the viability of the Murrurundi Dam after the implementation of the Scone to Murrurundi pipeline. A report on this matter will be provided to the April meeting following consultation and review by external organisations such as DPE, NSW Health, and NSW Fire.

#### **Key Activities**

#### **UHSC Damages Claim AGRN 987 (Event 6)**

Damages claim *AGRN 987* relates to the storm event of 6 November 2021 (Event 6) and includes **683** identified damages across Council's road network.

AGRN 987 Essential Public Asset Reconstruction (EPAR) response application was submitted to TFNSW on 6 October 22.

TFNSW has given the approval to proceed with a letter sent to Council on 13 December 2022 advising that funding of \$2,971,840 has been approved.

Works have commenced onsite to repair the flood-damaged roads in the EPAR claim and the completion of works has been recorded in the recovery database.

#### Damages Claim for UHSC (AGRN 987) - Design and Investigation Package

UHSC submitted EPA restoration form for the Design & Investigation Package for flood damage to TFNSW on 11 November 2022.

Flood damage details for the following roads -

- Ashbrooke Road
- Coulsons Creek Road
- Ridgelands Road
- Rouchel Road

Following a tender evaluation process, the council has provided a recommendation to TFNSW for the engagement of a professional services consultant, RHM Consulting Engineers in Scone, to start the investigation and complete the necessary design works.

Council has submitted a strategic estimate for the construction works for all 6 flood-damaged sites.

Council has also prepared Minor Works Request for Quotation for all 6 flood damage sites.

TFNSW to review the strategic estimate and the EPAR Claim for the construction works

#### UHSC Damages Claim AGRN 1012 - Landslip on the Barrington Tops Forest Road

Council has submitted a flood damage claim to TFNSW in relation to AGRN 1012 for the damages related to the landslip on the Barrington Tops Forest Road.

A proposal for a geotechnical assessment has been confirmed and JC Geotechnics has been commissioned to carry out the geotechnical investigation and design works for the above project.

The contractor has completed the onsite borehole investigation works and provided a geotechnical factual report to council.

Council has also prepared a Review of Environmental Factors for Barrington Tops Forest Road. TFNSW has given verbal approval to proceed and a formal funding letter is to follow. TFNSW to review the strategic estimate and the EPAR claim for the construction works.

#### **UHSC Damages Claim AGRN 1012 (Event 7) Cullingral Road (Crown Reserve)**

Council has estimated the value of the damages claim to be \$223,000. The EPAR application was submitted to TFNSW on 12 January 2023.

#### **UHSC Damages Claim AGRN 1034 (Event 8)**

Council has estimated the value of the damages claim to be \$1.25 million. The EPAR application was submitted to TFNSW on 11 January 2023.

#### **UHSC Emergency Claim AGRN 1034 (Event 8)**

Council is currently working onsite to document the emergency works using the recover database. Program of works submitted to TFNSW.

#### **Fixing Local Roads Pothole Repair**

Council has been successful in securing funding from NSW Government under the Fixing Local Roads Pothole Repair Round to the sum of \$591,431.97. Works to include routine and corrective maintenance of potholes in rigid and flexible pavements, sealed and unsealed roads. Staff will be concentrating on corrective maintenance across our sealed road network due to the number of hazardous sections requiring urgent attention.

#### Regional & Local Roads Repair Program

Council has been successful in securing funding from NSW Government under the Regional & Local Roads Repair Program to the sum of \$3,200,739.00.

Council staff and contractors will be working together to deliver these programs in 2023.

#### **PURPOSE**

The purpose of the report is to provide an update on the Coulson's Creek Road (MR358) Rehabilitation Project.

#### RECOMMENDATION

That the Committee receive the report and note the information.

#### **BACKGROUND**

Upper Hunter Shire Council undertook the construction of the Merriwa to Willow Tree Road (Coulson's Creek Rd, also known as MR358) in December 2019.

Cracking of the pavement and downslope fill embankment appeared after completion of major earthworks in October and November 2019. Further cracking developed in February 2020.

Council engaged geotechnical engineers and after an initial site inspection on 3 March 2020, the geotechnical advice on the condition of road and associated infrastructure was to impose a 5 tonne load limit and single lane configuration. Further geotechnical investigations, fieldwork and daily, weekly and monthly monitoring has continued since then.

A Project Control Group (PCG) was formed in September 2020 with representatives from Upper Hunter Shire Council, Transport for New South Wales, Infrastructure New South Wales and Public Works Advisory. The PCG has been charged with managing the road and the related design and construction phases of the project.

In January 2021, the PCG recommended following the latest geotechnical inspections, that the road be closed to all traffic with the key criteria of cracking extending to and beyond the centreline of the road.

The remediation works completed appear to have settled with only minor changes over the last six months.

#### **Construction Rehabilitation Tender**

The tender closes 16 March 2023 at which time submitted tenders will be evaluated with a recommendation to Council for adoption and award submitted to the May 2023 Council meeting.

Funding applications are currently undergoing final review by both the State and Federal Governments. Once completed Council will be issued with a funding deed for execution.

The funding for the project has been given in principle approval by both State and Federal Governments.

As noted previously in this report, an inspection at the toe (bottom) of the major failure revealed it has now reached the gully. Council staff have reported to the Environmental Protection Agency (EPA).

The rehabilitation and construction of Coulsons Creek Road is a substantial risk that will require appropriate management and control throughout the construction works.

#### e. Sustainability Implications

There are some significant environmental issues that include mass fill movements, tree loss, erosion and sediment controls. These must be addressed in the design process and form part of the review of environmental factors.

As noted the toe of the major failure has reached the gully. Council staff have reported this to the Environmental Protection Agency. Council staff are currently in consultation with stakeholders, specialists and authorities to determine the best method to control the sediments entering the watercourses.

#### Cr Campbell

Does council have a plan for the long-term upgrade of the Cullingral road Merriwa? This plan is essential to address the drainage and grading problems that now exist which are exacerbated by wet weather. In dry times the surface material is of a sandy nature that will not bind to form a stable surface. Stabilising with suitable material is required.

#### Response:

Cullingral Road is identified for upgrade in the 10 year capital works plan and the current Delivery Program with \$350,000 allocated in 2024/25 for shoulder widening and pavement rehabilitation of the sealed section. Gravel resheeting of the unsealed section will be undertaken as scheduled from within current budget allocations.

It is noted that some repairs and heavy patching is also proposed to be undertaken on Cullingral Road as part of a flood damages claim currently being assessed by TfNSW.
